What has been done in practice for GDPR compliance in a complex startup incubator-like environment with many teams, many products and heavy usage of cloud services.

GDPR does not prohibit personal data processing. It just sets rules to protect people from *unwanted* personal data use.





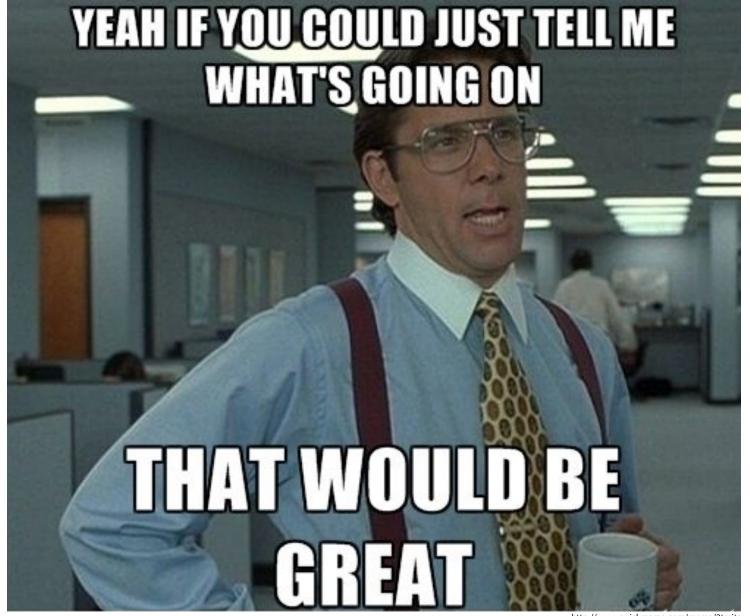

Understanding personal data processing



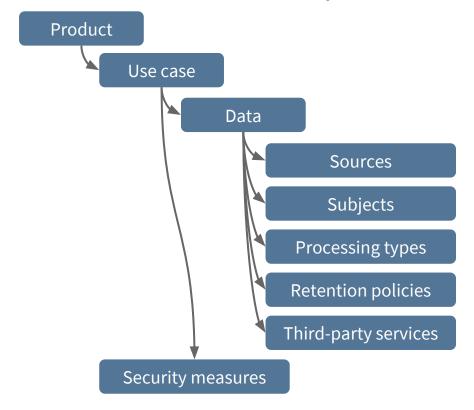


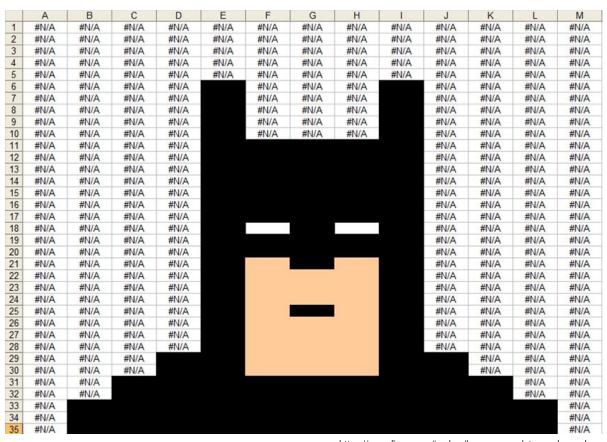
- Where are we processing personal data?

Data we needed had several layers:

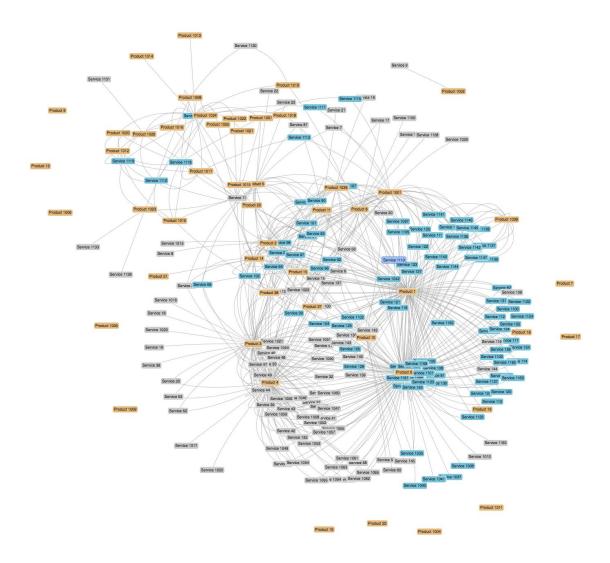

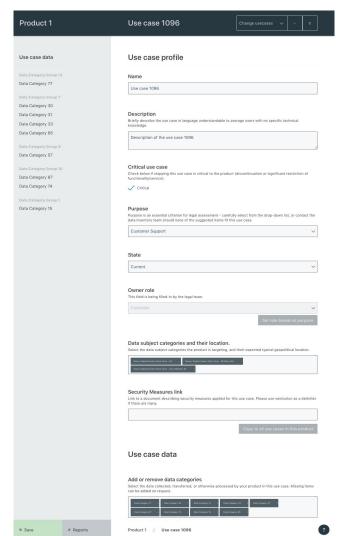


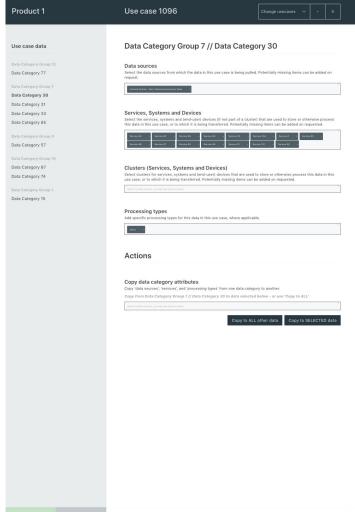
The scale of the problem



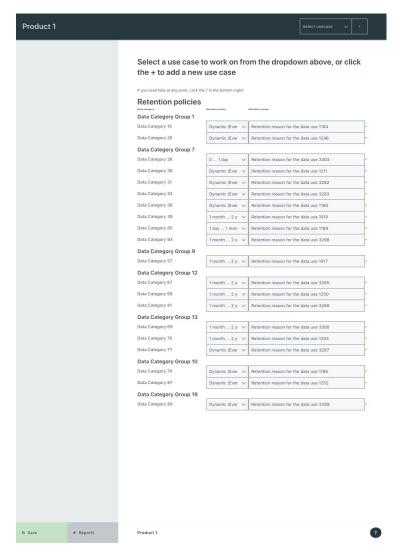


The Data Mapping Tool

Data processing

Single checks

"can I trace this user session for product improvement?"

make a REST API call before tracing

Bulk latency insensitive checks

"which users in the audience agreed to marketing?"

get a decision dump, merge
 with the audience, filter out
 those who didn't agree



Data processing

Latency sensitive or extremely bulky checks

"Can I personalise this banner?", "Who can I provide personalised offers?"

— a local cache updated real-time from a changes queue

Problem statement

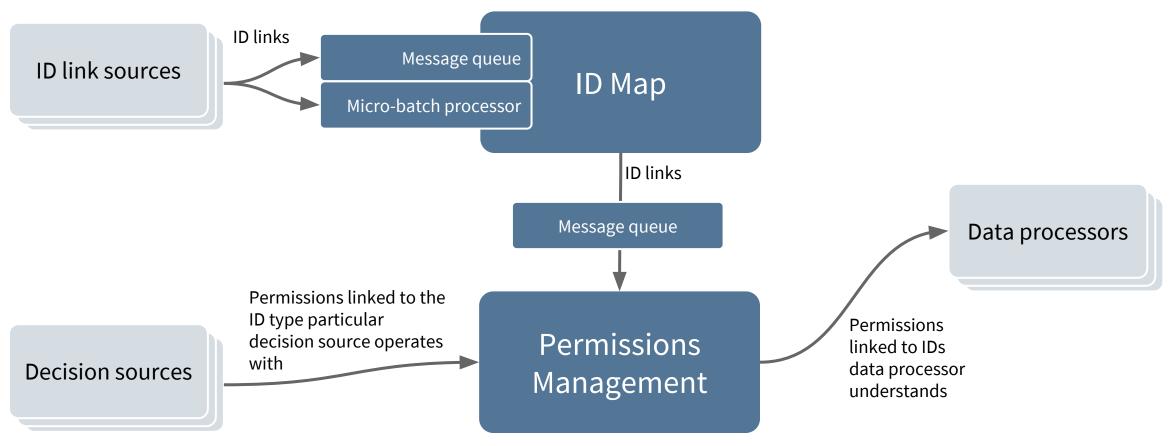
- Permissions Management UI uses Telenor's global customer identifier — **CONNECT ID**
- Some data processing systems use different customer identifiers and have no clue about related CONNECT ID
- Some of them even use subscription identifiers
- Programmatic marketing platforms use... cookies!







The solution: a bit of master data management

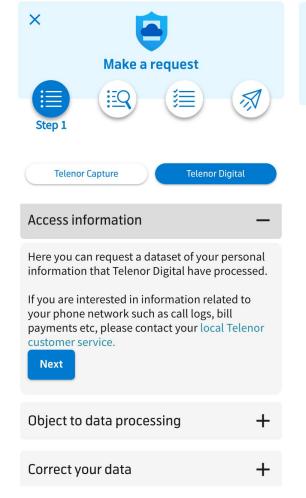




Data subject right requests automation

You should have in mind that your personal data is personal to you, and so should store the archive securely on download.

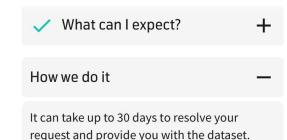
What can I expect?

The dataset may not be in a very readable format. Here are examples of what you might receive:

From CONNECT ID:

- Profile information such as name, email, phone number
- Locale activation code and it's timeout





- Customer Care will receive your request after you submit it. They will get in contact with you if they need extra details.
- The correspondence between you and Customer Care will be in English.
- As soon as the dataset is ready,
 Customer Care will send you an email with a link for downloading.
- You can also find the dataset under the see your downloads page.

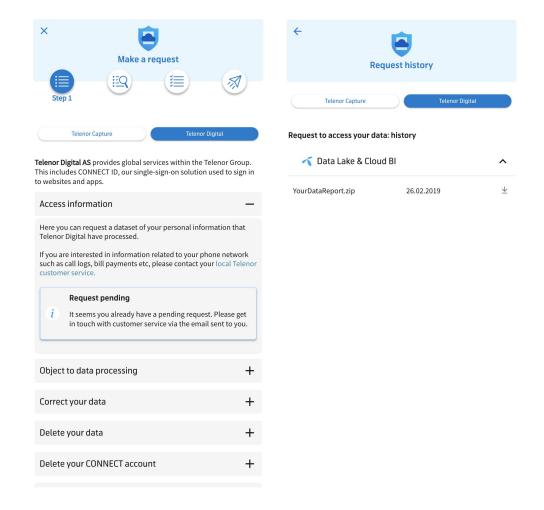

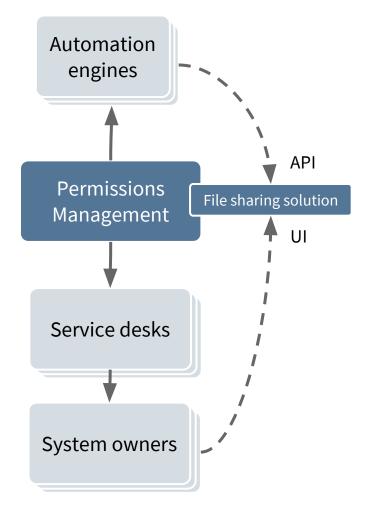
