



Event Data Privacy Consent (Saudi Arabia Operations)

1. By registering for this event, you agree to allow **Hyperight MEA Events Management L.L.C.** (The Event Organiser), located at The One Tower, 39th Floor, Al Barsha Heights, Dubai, UAE, to use the information provided in the registration form to process your registration, inform you about program updates, and manage event preparation and post-event follow-ups.
2. By registering, you acknowledge that your personal data will be processed on these platforms, which involves the transfer and storage of data outside the Kingdom of Saudi Arabia to the UAE or other jurisdictions. These transfers are conducted in accordance with SDAIA's cross-border transfer regulations, ensuring appropriate safeguards such as Standard Contractual Clauses (SCCs) are in place to protect your data.
4. Hyperight may share your basic information (Name, Title, Company) with selected Partners sponsoring the event for pre-event preparation and post-event evaluation. Partners are obliged to fulfill PDPL standards, maintain data confidentiality, and provide a clear opt-out option for any future communications. The Co-Host is required to comply with PDPL direct marketing regulations, ensuring you have a clear mechanism to opt-out of further contact.

If you are registering for specialized sessions, including workshops or roundtables, Hyperight holds the right to share your basic information (Name, Title, Company, Email, and Company Telephone) with the session moderator for preparation and follow-up activities. These parties must adhere to PDPL standards and ensure data is used only for the purpose of the session.
